How to enter:

1. Entry to this competition is by purchasing any 12 bottles of Angullong Wine via the Angullong wine website at www.angullong.com.au or in the cellar door in Millthorpe NSW.

TERMS AND CONDITIONS

1. This competition commences at 9:00am EST on 28 Aug 2019 and closes at 5:00pm AEDST on 5 October 2019 ('Promotional Period'). Taking part in this competition constitutes acceptance of these Terms and Conditions.

2. The Promoter of the competition is Angullong Vineyard, ABN 28367379841, 2723 Four Mile Creek Road, Panuara, NSW 2800 ('Angullong').

3. To enter, persons must purchase any 12 bottles of Angullong Wine from the Angullong website, www.angullong.com.au during the Promotional Period. Purchases online constitute automatic entry into the promotion.

4. This promotion is only open to residents of New South Wales.
